- monitoring, recording and analysis of accidents, injuries and near misses;
- the provision of appropriate **Personal and Collective Protective Equipment** (PPE and CPE), the availability of **safe work machines** and **ergonomic workplaces**;
- the adoption of technical-organizational measures for **fire prevention and protection** and to deal effectively with **emergencies**;
- implementing effective communication programs to promote the awareness and the involvement of all the staff, suppliers, shareholders and other stakeholders towards the prevention of health and safety risks and environment protection.
